Along with many of the Breakfast with Santa staples such as the trains, arts and crafts, the silent auction and of course Santa, this year also included the Wells Fargo stage coach. The stage coach was a wonderful addition and a great activity for all ages. This is always an event we consider special as it is truly for the children. We are excited to announce that we made \$24,000 on this event.

The King's Daughters held the Moonlight & Mistletoe event at the Norfolk Waterside Marriott. Our major projects are focused on raising funds for a new transport unit. This mobile neonatal care unit and its transport team save lives when time is of the essence. The unit is specifically designed for the needs of our children and therefore costs \$650,000. Over 200 King's Daughters gathered to celebrate their hard work and dedication on October 6, 2015 at the Norfolk Yacht & Country Club. The night began with a welcome from The King's Daughters President Beth Johnson, who thanked everyone for their service and progress towards The King's Daughter's mission. CHKD President Jim Dahling also acknowledged the amount of volunteer hours each member has contributed. 
PROCEEDS

CRITERIA AND EXPECTATIONS THE KING'S DAUGHTERS BOARD OF DIRECTORS

A candidate for membership on the BOARD OF DIRECTORS of THE KING'S DAUGHTERS should meet the following criteria:

Criteria/Qualifications:

- Be a member of a King's Daughters Circle for a minimum of two years.
- Have worked on a Major Project or been the Chair of a Circle project or been a Circle Leader.
- **May not be an employee of Children's Hospital of The King's Daughters.**

Expectations:

- Ability to attend monthly board meetings.
- Ability to attend board committee meetings as necessary.
- Ability to attend KD Connect meetings (4-5 per year).
- Ability to serve as a liaison to Circles.
- Ability to become a hospital tour guide.
- Ability to sign a conflict of interest form and confidentiality agreement.
- Ability to become educated in the workings of The King's Daughters and the other corporations under the umbrella of the Children's Health System, Inc.
- Ability to support CHKD's Annual Giving Campaign.
- Ability to support and attend The King's Daughters' Major Projects each year.
- Ability to act as a spokesperson for The King's Daughters.
- Possess a demonstrated commitment to community service, support for The King's Daughters mission and values.
- Willingness to accept additional duties as assigned by The King's Daughters Board of Directors' President.

Please Note:

All KD Board of Directors members:

- **May not hold a leadership office in their own Circle or on a Major Project's committee unless approved by The Executive Committee of The King's Daughters Board of Directors**
- **May not serve as their Circle's representative at KD Connect Meetings**
- **With the exception of The King's Daughters' President, who is a Class A member of the Children's Health System Board and an Executive Committee Member who automatically serves as a ex-office member on the Children's Health Foundation Board, a King's Daughters Board Member may serve on a Children's Health System affiliate Boards with the approval of the Executive Committee.**
